

### GENERAL TERMS AND CONDITIONS FOR CAMPAIGN ("CAMPAIGN T&C")

- 26. Participant shall indemnify and keep the Boost Credit fully indemnified from and against all actions, suits, claims or demands, proceedings, losses, damages, compensation, costs (including reasonable legal cost), charges and expenses whatsoever to which the Boost Credit shall or may become liable in respect of or arising from any non-compliance or breach by Participant, its officers, agents, or employees of any provisions under this Campaign or any applicable laws in the performance of any of its obligations under this Campaign.
- 27.
